The 9th Edition of the State Building Code is expected to be adopted later this year and become mandatory in January, 2018. It will be based upon the 2015 International Building Code. This presentation provides an overview of the more significant changes to the State Building Code in the 9th Edition as compared to current and past editions. Comparisons and examples are provided to highlight key differences.
