



# WMAIA Celebration of Architecture and Design Awards Program 2024

In partnership with the Western Massachusetts Section of the Boston Society of Landscape Architects, this longstanding bi-annual program of the WMAIA aims to encourage and recognize distinguished architectural and landscape design achievement and honor the project team – including the clients and consultants who work together to improve the built environment. Participation in this program involves sharing your work at the WMAIA Annual Meeting on December 17, 2024, regardless of whether your project has been selected for an award.

The Western Massachusetts AIA/Western Massachusetts BSLA Design Awards Program recognizes and honors excellence of all types of buildings designed by architects & landscape architects — members and non-members— practicing in the Western Massachusetts region.

# **ELIGIBILITY**

Any building type or landscape project anywhere in the world completed at any time in the last seven years (after January I, 2017) is eligible, if the architecture firm/architect-of-record or landscape architect currently has its principal office in Western Massachusetts, which is defined for the purposes of this program as Berkshire, Franklin, Hampden and Hampshire counties or if the architect having a lead project role (i.e., Project Principal, Project Designer, Project Architect, Project Manager) is a member of WMAIA.

Eligible projects may be new construction or renovations and may be projects for private or public clients. Projects that previously received awards through this program are not eligible.

Any eligible architect/firm and/or landscape architect/firm may submit any number of

qualifying entries provided each is submitted separately with the appropriate registration fee.

# **CRITERION**

The foremost judging criterion is design excellence. The judging will be informed by the AIA Framework for Design Excellence, which contends that design is not solely about aesthetic components, but also concerns how buildings perform for people. The Framework for Design Excellence is made up of 10 measures (see link under "Submissions" section for further information).

We invite submissions of:

- Works of Architecture
- Works of Landscape Architecture
- Interdisciplinary Work (Architecture + Landscape Architecture)

## **AWARDS**

Awards will be presented at WMAIA's Annual Meeting on Tuesday December 17, 2024 at the John Olver Design Building at UMass Amherst. All project entries will be recognized at this event.

Projects submitted for this program will be highlighted on the "Featured Projects" page of our website (wmaia.org) for the next two years and promoted through our social media channels.

Awards are to be issued at the discretion of the jury and will be recognized as follows:

- Honor (1st) bestowed for exceptional work, easily distinguishable by exceptional quality of design and function
- Merit (2nd) bestowed for work that demonstrates a high level of design quality worthy of recognition
- Citation (3rd) bestowed for work that demonstrates a level of design quality worthy of mention

# **JURY**

This year's awards will be juried by colleagues in AIA Greenville SC. Our distinguished jurists are:

Professor and the acting Assistant Director in the School of Architecture at Clemson University, where he leads design studios and teaches structures seminars. # STEP 1.

Fee Payment/Registration

**DEADLINE:** Projects may be registered anytime up to the Portfolio Submission deadline of Friday October 1lth.

Projects that are registered by September 25th receive a \$25 discount. Discount code EARLY. Fees are non-refundable.

**AIA/BSLA members:** \$125 for first submission, \$25 per additional submission. **Non-members:** \$175 for first submission, \$50 per additional submission.

We will be accepting submissions digitally only. We prefer that you submit via a cloud-based platform; Dropbox is strongly preferred.

# **SUBMISSIONS ORGANIZATION**

Materials must submitted in four files, in a digital portfolio format no larger than 12" x 18" and not to exceed 18 pages (Landscape Architects may want to submit 8-1/2" x 11" to match the BSLA awards criterion).

Please standardize all pages of the portfolio for ease of viewing – all pages must be the same size and oriented in the same direction (portrait or landscape).

If possible, please upload these four files in a folder; one folder per project. Name the files and folders as decribed below. **Send the file link to director@wmaia.org.**

Do not include any identification of entrant/project team.

## Do not include any identifying information.

300 words maxium. The jurors have limited time with each project; tell a clear and compelling story about your project. Content and presentation should be clear and concise.

Include:

- · Germination of project
- · Client goals
- Project / designer intentions
- Programming requirements
- Cost data
- Distinguishing aspects of your project resolution
- · Client, community and user impact
- Metrics that your project is meeting, such as LEED, Passive House, SEED, LBC, WELL, Fitwel, etc.

# PAGE 3 - AIA FRAMEWORK FOR DESIGN EXCELLENCE

Using the AIA Framework for Design Excellence, describe how your project addresses these measures of excellence.

The intention is to highlight the area(s) in which your project excels, rather than a laundry list of measures. **This infographic is helpful**.

# PAGES 4-18 - PROJECT IMAGES Maximum 15 pages.

- Color or black and white images illustrating exterior and interior views of the project.
- In addition, provide drawings such as diagrams, a site plan, typical floor plan(s), elevation(s) and/or sections(s), etc. as necessary to understand the project.
- Use image captions to highlight areas of excellence that tie back to measures from the Framework and to clarify image content.
- Restoration projects: include one or two images showing the original structure.
- Interiors projects, include one or two images of the project exterior (and indicate whether or not you also designed the exterior).

• Unbuilt projects: submit as many of the suggested drawings as possible. Note clearly that it is an unbuilt project.
